NOTICE OF PUBLIC HEARING

The Hood County Commissioners' Court has received a petition to create
Hood County Emergency Services District No. 1

The District is to be created and is to operate under Article III, Section 48-e, of the Texas Constitution, as proposed by S.J.R. No.27, Acts of the 70th Legislature, Regular Session, 1987, and adopted by the voters at an election held November 3, 1987.

The name of the proposed district is Hood County Emergency Services District No. 1.

The boundaries of the District are as follows:

Starting where the DCBE/Acton Volunteer Fire District's boundary intersects the edge of Lake Granbury, near the termination of Rhea Ct. at Lake Granbury, following the edge of Lake Granbury south until the DeCordova Dam.

Then following the north edge of the Brazos River until Pecan Plantation.

Following the northern boundary of Pecan Plantation until its intersection at the Brazos River, east of the Pecan bridge, Then following the edge of the Brazos River until the Hood County boundary.

Following the Hood County boundary north (until it intersects with the Cresson Fire District boundaries.

Then following the boundary of the DCBE/Acton Volunteer Fire District to Hwy 377 just east of Industrial Ave.

Following the boundary of the DCBE/Acton Volunteer Fire Department fire district until it terminates at the edge of Lake Granbury, near the termination of Rhea Ct.

Western and Southern boundary shall be the edge of Lake Granbury and the north edge of the Brazos River from Rhea Ct. to the county line, excluding the property of the subdivision of Pecan Plantation. East boundary shall be the county line until its intersection with Cresson's fire district. Northern boundary shall be the Cresson Fire district boundary and the DCBE/Acton Volunteer fire district until its intersection with Lake Granbury.

Copies of the Petition are available for public view in the offices of the Hood County Clerk and Hood County Elections Administrator.

The Public Hearing will be held in the Central Jury Room of the Hood County Justice Center at 1200 W. Pearl Street, Granbury, Texas 76048 at 9:00 a.m. on Tuesday, May 25, 2021.

Each person who has interest in the creation of the District may attend the public hearing and present grounds for or against creation of the District.
