### V. Business to be Discussed and Considered for Approval:

#### 1. Consider the proposed increase in tax revenues of the proposed budget:

- a. \$528,787 or a 2.1% increase (tax rate \$0.283424) or (average homeowner would pay 70.00 less)
- b. \$632,578 or a 2.5% increase (tax rate \$0.284575) or (average homeowner would pay \$67.00 less)
- c. \$907,339 or a 3.5% increase (tax rate \$0.287622) (average homeowner would pay \$56.00 less)

and take a record vote regarding that increase, per Local Government Code, Section 111.008(c). (AUD. CJ)

#### 2. Consider proposed budget that was the subject of a public hearing on Tuesday, August 22, 2023, for Hood County Fiscal Year 2024, including any changes as agreed; and take a record vote regarding that budget.

(Local Government Code 111.008 and 111.009 and Tax Code chapter 26).

The 2024 current proposed budget with changes from August 22, 2023 through September 11, 2023 is on the County website. (AUD. CJ)

3. Consider whether to adopt the order to set the Hood County Property Tax rate at:

- a. tax rate \$0.283424 or
- b. tax rate \$0.284575 or
- c. tax rate \$0.287622

per \$100 valuation (which is less than last year's rate) for the tax year 2023, and take a record vote on the Tax Rate Order per Local Government Code 111.010 and Tax Code Chapter 26. (AUD. CJ)

4. Consider and take appropriate action to approve the 2024 Salary Matrix, setting salaries as of October 1, 2023. (AUD. CJ)
