Hood County COVID-19 Interim Update - 04-19-2021, 3 PM

This is an update based on numbers from reports received from our testing locations on positive cases in the community to DSHS for Hood County.

DSHS Reports a total of **6449** COVID-19 positive cases have been detected in Hood County residents. (There have been 46 New Cases reported for April as of today) (38 Active Cases)

We are at **126** COVID-19 positive deaths reported by DSHS for Hood County residents. (3 new deaths since the last update)

We have tested a total of **56,724** citizens in Hood County.

Our TSA Regional Hospital Rate as of 04/18/2021 is **3.42% - 11.58%** under the 15% threshold required by the state.

5 currently reported hospitalizations, all other active cases have been directed to self-isolate at home.
