## HOOD COUNTY 911 ADDRESS REQUEST

Information gathered is used to help emergency service personnel respond to 911 calls. This form must be completed for all habitable structures in Hood County. Please note that the naming of road or assignment/re-assignment of an address is a ministerial act. Hood County, its employees or agents, do not warrant or assure that any road or easement is public or private nor what parties or landowners have a right to use said easement.

(\*After receiving notification of address, please post it on your mailbox using 3" reflective numbers and home or gate, using 4" reflective numbers to aid in emergency response. If your residence is not close to your mailbox, it is **imperative** that the entrance to your property **AND** your structure be marked with your address number. Address **must** be visible from both sides of the road. If you are **not** going to use this as your mailing address, it is still important that you display the address numbers for emergency services. If you live on a State Hwy, you must contact TXDot for placement and installation of your mailbox, 254-897-2647. On County roadways, the mailboxes should be no closer than 1 foot from the road or further than 3 feet. If you have any questions on mailbox placement **OR** are going to construct a driveway, fence, etc., please contact the office of County Road Operations 817-579-3304 for County right-of-way regulations. This does not apply to private lanes.)
