The following schedule of fees shall determine the compensation to be paid to counsel appointed to defend indigent persons in the 355th Judicial District Court, effective 10-01-2021:

Plea of guilty to the court for 1 st or 2 nd Degree* Felony	\$775.00

2. Representation in a Motion to Revoke Probation or a Motion to Proceed with Adjudication of Guilt	\$600.00 if contested*
a) If involving multiple cases	\$475.00, if based on plea

*for contested Motion to Proceed with Adjudication of Guilt with punishment range of 2 nd Degree or 1 st Degree felony, \$700.00	
3. Representation resulting in an Order of Dismissal of indictment prior to plea, if based on work of defense counsel, and with supporting documents.	\$350.00, max
a) Multiple cases dismissed prior to indictment based on defense counsel work, and with supporting documents.	\$500.00
4. Representation resulting in substitution of counsel	\$350.00, max, with supporting documentation
5. Representation in a Motion for Shock Probation	\$300.00
6. Representation of multiple cases involving a single Defendant resulting in a Plea of Guilty or Nolo Contendere to the Court and disposition of all cases	\$850.00
7. Trials (Jury and Non-Jury)	a) \$450.00 per half day PLUS
	b) \$125.00 per hour for trial preparation (15 hr. maximum w/supporting documentation)
8. Filing Motion for New Trial	\$125.00, without hearing
	\$250.00, with hearing
9. Appeal to the Court of Appeals	\$1,350.00 (brief plus oral argument)

10. Representation in Petition for Discretionary Review	\$300.00
11. Appeal to the Court of Criminal Appeals	\$850.00
12. Post-Conviction writ of habeas corpus proceeding	\$500.00
